## PLAYER LOAN RULES

- Following the conclusion of Zone League, each Division 1 team may loan 1 player from a non-qualified Division 1 team within the loan window in September as noted above. Division 2 teams may loan 1 player from a non-qualified Division 1 and 2 team.
- Loans are only granted at the discretion of the loaning club. Clubs, Associations and Players are not allowed to charge Transfer and Loan Fees.
- Loans may only be withheld by a Club if a player has an unsatisfied financial obligation (whether disputed or not) to the club for which an Invoice or other formal documentation supporting indebtedness to the Club has been issued prior to the application for transfer is received by the transferring Club.
- Where a financial obligation between a Club and player is unable to be resolved this will be referred to VNZ for resolution. VNZ decision will be final.
